Register for the 30 Hr. courses on-line at www.myflorida.com/childcare then click **“Training Login”**
Enter email & password then click under **Instructor Led or Online Courses Enroll**. Select the training period (months). Select **Orange** for the county and **Community Coordinated Care for Children** for the Training Provider. The courses will populate on the bottom of the screen, then select courses.
