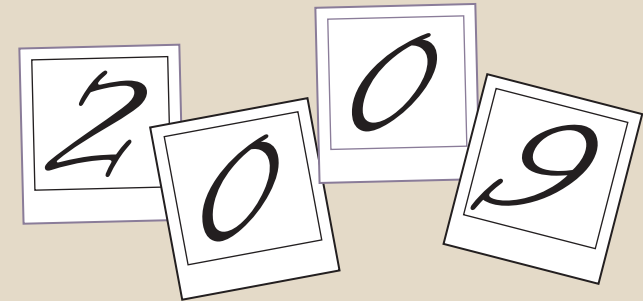

As we review the accomplishments of 4C this past year, we can't help but reflect on the appreciation that we have for being part of an agency with a history of supporting children and families for over forty years. In our nation's current economic state, 4C services continue to be a priority need in our community. We can attest that 4C will continue its legacy of **"Caring for Our Future Today."**

In December of 2009, 4C was approved by the U.S. Department of Health and Human Services, Administration for Children and Families, to begin providing Early Head Start (EHS) services in Orange, Osceola, and Seminole Counties. EHS is a federally funded program for less advantaged infants and toddlers (birth to age three) and also provides services like fetal development education and pre-post natal care to expectant mothers. 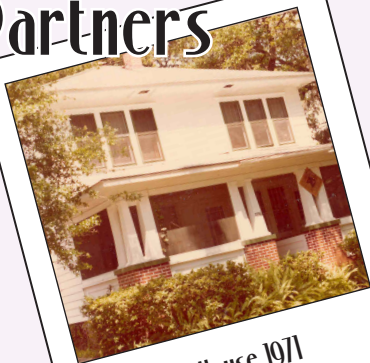
