The goal of the Head Start / Early Head Start program is to bring about a greater degree of social competence in children with low income families, taking into account the inter-relatedness of cognitive and intellectual development, nutritional needs, and other factors.

The results of the most recent review by the Secretary of HHS and the Financial Audit:

Most recent review by the Secretary of HHS

The Triennial Head Start/Early Head Start review was conducted in December 2011. A Summary Letter indicated zero deficiencies and Seven non-compliances. The program was given 120 days to resolve non-compliances and has done so.

In January 2012, the CLASS was performed in Head Start classrooms. Though scores in all domains were within the tool's threshold for providing developmentally appropriate interactions, the score on the Classroom Organization was in the bottom 10%.

Financial Audit

The most recent independent financial and compliance audit conducted by a Certified Public Accounting firm for the year ended December 31, 2011, resulted in an unqualified opinion, no management, and no findings or questioned costs.

Services to Children and Families

The Agency's efforts to prepare children for kindergarten:

Head Start

The program uses research-based *Creative Curriculum* with a thematic approach. A web-based assessment system creativecurriculum.net is used to track the progress of children in the eight domains of Language Development, Literacy, Mathematics, Science, Creative Arts, Social and Emotional Development, Approaches to Learning, and Physical Health and Development.

Of the children served during the Head Start school year, 319 moved onto local kindergartens. Transition activities that both our parents and children participate in help acclimate and improve their preparation for kindergarten. Achieving 100% using outcome statistics is difficult because of the transitory nature of our communities and of the families served. As previously mentioned, the funded enrollment is 526, but 624 children were served during the year.

Early Head Start

The program helps form the critical foundation during the period birth to three which will positively influence each child's later learning habits. Key during this period is the development of trust in an adult caregiver and a strengthening sense of security. Facility environments are designed to allow infants, toddlers, and twos to explore, to the extent they wish, all the age-appropriate materials provided in their surroundings. 4C utilizes the ITERS (Infant Toddler Environment Rating Scale) to ensure the environment in which our children are cared for meets or exceeds all developmental criteria. Preparation for Kindergarten becomes even more of a focus when the three year old enters the Head Start program. The development of these necessary educational skills will have a much stronger footing thanks to the EHS experience in their formative years.

Funded enrollment and total number of children served during the program year:

4C Head Start/Early Head Start is funded to provide services to 774 children. During 2011-2012 both programs provided service to 1,070 children and 976 families. The program maintained 100% enrollment throughout the year. Most of the children served were income eligible (including children below 100% poverty line, on public assistance, foster children, and homeless).

Our Head Start / Early Head Start programs are required to verify family income before determining a child is eligible to participate in the program.





Program Volunteers

Volunteers have an important role in the Head Start /Early Head Start programs. In 2011-2012, volunteers provided 58,108.39 hours of valuable services amounting to \$690,327.68 toward both programs Non-Federal match in funding. We need parent/guardians to strongly consider volunteering their time at least once a week to assist in our programs. As part of the Head Start and Early Head Start programs, parent/guardian involvement is included as part of the Head Start and Early Head Start programs. Parent/Guardians are also encouraged to work on different activities with their child in the home. In this way, parent/guardians assist in the reinforcement of new skills or concepts introduced in the classroom and during home visits. This also helps to assist in meeting each child's individual goals. 4C Head Start / Early Head Start needs the involvement of parents, families, community members, 4C Board of Directors and members of policy groups to conduct activities for the Head Start / Early Head Start programs. The reasonable value of the time donated/volunteered by people, while conducting activities in assisting in our programs, will help with the contribution of non-federal funds required by the funding grant directives.

Head Start / Early Head Start, health services for all children include medical and dental screenings, follow-up for identified problems, nutrition screenings, growth tracking, health and nutrition activities in the classrooms and on home visits, and parent information on health. Head Start has a goal of helping each family establish a long term medical home for quality care. In order for us to protect all children enrolled, do not send your child to school if he/she has any contagious illness or condition - if you are not sure, contact your child's teacher. If your child needs to take medication during school hours, you must sign a prescription release form. The form will allow the teacher (s) to give the medicine at the right time. All medicine must be in its original container. Most doctors are aware of this licensing requirement and will give you two prescriptions - one for home and one for child care center.

Mental Health - Disability Services

Our goal in Early Head Start/Head Start is to provide environments most likely to help children make fullest use of their potential as preschool learners. Mental Health and Disabilities Services assist families and teachers in identifying children who could benefit from additional support. The screenings and Early Steps/school district evaluations are designed to deepen the understanding of each child's current strengths and skills, and in no way predict a child's future skills or abilities. Early support and intervention create the greatest opportunities for success.

Health services for all children include medical and dental screenings, and follow-up for identified problems discovered during the initial screenings; in addition, Health Services provides nutritional screenings, growth tracking, and nutritional activities in the classrooms and on home visits. Parents also are provided information on health and nutritional issues while in the classrooms and during home visitations. The 4C Head Start program has established a goal/standard of helping each family obtain and maintain long term medical care for quality home care.
