## <u>HS/EHS/CCP/EXP Budget, Financial Statements & Non-Federal Share Report – November/December</u>

Kelly presented program information: HS 42% program year completions, 39% budget completion. EHS also 42% through program year, 38% budget completion. EHS-CCP is 33% through program year, 31% budget completion. EHS-EXP 75% program year completion, 74% budget completion. (November)

Kelly presented program information: HS 50% program year completions, 47% budget completion. EHS also 50% through program year, 45% budget completion. EHS-CCP is 42% through program year, 37% budget completion. EHS-EXP 83% program year completion, 81% budget completion. (December)

#### **HR Report – February/March**

## <u>Director's Report – January/February</u>

January: Enrollment Numbers HS 270/396, EHS 168/249, CCP 196/252, EXP 87/150. Attendance is down ranging from 64-80% with EXP being the lowest. Disability numbers range from 2.4 to 8.96% again with EXP being the lowest. All numbers still impacted by COVID-19.

February: Numbers HS 267/396, EHS 168/249, CCP 195/252, EXP 92/150. Attendance improved from previous month, ranging from 76-83% with EXP being the lowest. Disability numbers saw a slight increase ranging from 3.3 to 8.5%, EXP remains the lowest. All numbers still impacted by COVID-19.

#### Self-Assessment

The Self-Assessment is completed annually and lead by the QA Team. Program includes both staff, community partners and parents in the process.
